Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations,

2016.

With effect from 1st April 2018, individuals are eligible to register themselves as Insolvency

Professionals (IP) only after undergoing through the mandatory 50 hours Pre-Registration Educational Course conducted by an Insolvency Professional Agency after his/her enrolment as

a Member.

The Pre-Registration Educational Course is conducted by an expert faculty who would share

their in-depth knowledge and experience in related areas. The Course will enhance the knowledge base, sharpen the management skills with efficiency in advocacy, code of conduct

and handling insolvency effectively.

In view of the advisories issued by various authorities in the wake of COVID-19, IBBI has issued

a Circular dated 20th March, 2020 which states that the mandatory 50 Hours training of Preregistration Educational Course will be conducted online till the 30th of September, 2020. It has,

accordingly been decided that pre-registration educational courses completed online during this period will be accepted for registration.

A view on reversion to classroom courses will be taken in due course.

IIIPI will conduct these online classes through "ZOOM" software. The link of the software has been provided below. All participants would be required to download this Application on their LAPTOP

and TABLET.
