Registration Educational Course from an Insolvency Professional Agency after his/her

enrolment as a Professional Member.

would share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and

handling insolvency effectively.

In Lieu of the current situation of COVID-19, and as per the IBBI Circular dated 10th

July, 2020, which states that the mandatory 50 Hour training of Pre-registration Educational Course will be to continue online delivery of education beyond 30th September, 2020, in addition to classroom mode, wherever possible. These online

classes will be conducted online.
