In Lieu of the current situation of COVID-19, and as per the IBBI Guidelines dated 03<sup>rd</sup> September 2021, which states that the mandatory 50 Hour training of Pre-registration Educational Course will be to continue online delivery of education till 31<sup>st</sup> December 2021. These online classes will be conducted online.
