Provisional List of IPs prepared in accordance with 'Insolvency Professionals to act as Interim Resolution Professionals, Liquidators, Resolution Professionals and Bankruptcy Trustees (Recommendation) (Second) Guidelines, 2020

IBBI has published a list of 826 professionals for appointment as IRP in a CIRP under section 16(4), liquidator in a liquidation process under section 34(6), RP in an individual insolvency resolution process under section 97(4) or 98(3), and bankruptcy trustee under section 125(4), 146(3) or 147(3) of the Insolvency and Bankruptcy Code, 2016, during the period January 01, 2021 - June 30, 2021.

### NCLT approves record number of resolution plans between Jan to Sept

Despite the challenges posed by the pandemic, a record 78 resolution plans were approved by bankruptcy courts in the first 9 months of 2020 according to Insolvency and Bankruptcy Board of India (IBBI) data. This is the highest number of resolution plans approved by National Company Law Tribunal (NCLT) in 9 months, since the inception of Insolvency and Bankruptcy Code (IBC).

Mahindra & Mahindra (M&M) owned SsangYong Motor Company (SYMC) has filed for bankruptcy. While there are enough instances of failed overseas acquisitions, the company bought from a court receivership by an Indian company, heading back to bankruptcy after a decade is unheard of.

# <u>Five-member NCLAT bench declines to reconsider decision on insolvency filing time frame</u>

A five-member bench headed by Acting Chairperson Justice Bansi Lal Bhat upheld that acceptability of debt entered in the balance sheet of a company will not amount to acknowledgment of debt for deciding the time frame for initiating insolvency proceedings. The Bench turned down a reference made by a three-member bench seeking reconsideration of an earlier decision related to deciding the time frame for initiating insolvency proceedings against a company.
