## **Further Extension of last date of receiving Annual Membership fees for the Year 2021-22**

Dear Member,

In terms of Clause 11 of the Model Bye-laws under Regulation 3 read with Regulation 2(1)(c) and Bye-Law 11 of the Bye-Laws of Indian Institute of Insolvency Professionals of ICAI (IIPI), the IPA may require the professional members to pay a fixed sum of money as its Annual Membership Fee.

The Governing Board of IIPI had decided the fee structure and payment procedure for its professional members as follows:

- Annual Membership Fee of Rs. 11,800/- (Rs. 10,000/- plus GST @ 18%).
- The fee for the year is payable in advance and is required to be deposited with IIPI on before 30<sup>th</sup> April of every year. Delay in payment beyond this date may attract late payment fee or other penalties, as applicable.

However, keeping in view Covid -19 pandemic, the last date of payment of the Annual membership fees for the Financial Year 2021-22 has been extended up to **30<sup>th</sup> June 2022** with late fee (Rs.1000/-).

Considering the above, you are requested to pay your Annual Membership Fees of Rs. 12,980/- (Rs.10,000/- + Rs.1000/- (late fees) + GST@18%) for F.Y. 2021-22 latest by **30<sup>th</sup> June 2022** . .
