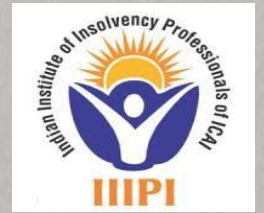

Indian Institute of Insolvency Professionals of ICAI (IIPI) is a section 8 (not-for-profit) Company established by the Institute of Chartered Accountants of India (ICAI) and constituted as a Public Ltd. Company. It has been awarded with the registration certificate as the first Insolvency Professional Agency (IPA) of India by Hon'ble Union Finance Minister Shri Arun Jaitley on 28th November 2016. IIPI has attracted members from a diverse stream including Chartered Accountants, Company Secretaries, Cost Accountants, Advocates and Management Professionals. Currently, IIPI manages 63 per cent of IP memberships as the largest IPA in India. The Governing Board of IIPI consists of eminent Professionals/Bankers/CAs including former IAS officers.
