## 1. Purpose

The Insolvency and Bankruptcy Board of India (IBBI) has introduced the Pre-Registration Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations, 2016.

With effect from 1<sup>st</sup> April 2018, individuals are eligible to register themselves as Insolvency Professionals (IP) only after undergoing through the **mandatory 50 hours** Pre- Registration Educational Course from an Insolvency Professional Agency after his/her enrolment as a Professional Member.

The Pre-Registration Educational Course will be conducted by expert faculties who will share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

*As per IBBI Guidelines dated 30<sup>th</sup> September 2022 which states that the mandatory 50 Hour training of Pre-Registration Educational Course will be to continue online delivery of education till further orders, these classes will be conducted online.*

## 2. Date, Online Portal and Fees for the Course

3. Participants **without an Enrolment Number** (from any IPA) will not be allowed to attend the Course.
