Purpose

The Insolvency and Bankruptcy Board of India (IBBI) has introduced the Pre-Registration Educational Course under Regulation 5(b) of the IBBI (Insolvency Professionals) Regulations, 2016.

With effect from 1st April 2018, individuals are eligible to register themselves as Insolvency Professionals (IP) only after undergoing through the **mandatory 50 hours** Pre- Registration Educational Course from an Insolvency Professional Agency after his/her enrolment as a Professional Member.

The Pre-Registration Educational Course will be conducted by expert faculties who will share their varied advice and experience. The Course will enhance the knowledge base; sharpen the management skills with efficiency in advocacy, code of conduct and handling insolvency effectively.

As per IBBI Guidelines dated 30th September 2022 which states that the mandatory 50 Hour training of Pre-Registration Educational Course will be to continue online delivery of education till further orders, these classes will be conducted online.
